Perumbavoor, Ernakulam, Kerala – 683544** should submit fresh online application through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Government Polytechnic College, Perumbavoor Koovapady, P.O. Perumbavoor, Ernakulam, Kerala – 683544** as a whole.
